To furnish the details regarding implementation of mechanism under prevention of Sexual Harassment of Women at Workplace Act-2013 in the Medical Institute and its associated Hospital for redressal reporting following will be the procedure:-

I. Procedure prescribed for submitting an online complaint:

- a. A formal written complaint must be filed as a hard copy / on email (deansolapur@gmail.com) within 90 days of the incident.
 - b. Content: -Date and Time of the incident.
 - -The Place where it occurred.
 - Name and Contact information of the accussed.
 - -Name and Contact information of the witnesses.
 - Detailed description of the incident.

c. Who can File?

- Any women/female student of Dr.V.M.Govt.Medical College & Shri.C.Shivaji Maharaj Sarvopchar Rugnalya, Solapur including the faculty and staff of this institue and hospital, as well as the Nursing students and Staff members in any capacity can file a complaint against an incident of Sexual Harassment.
- Any student irrespective of age can file a complaint against an incident of Sexual Harassment.

d. Where to file?

- The written complaint must be filed as a hard copy to ICC through proper channel.

III. Complaints from the above categories of the complainants will be dealt with as per the mechanism under prevention of Sexual Harassment of Women at Workplace Act-2013.
